SunEdison, Inc. With that strategy, the battery will last the greatest number of days/years. If the battery is going to sit unused for weeks, discharge it to about 50% first. Do NOT full-charge, then let it sit. Fully discharging is bad for battery life. You only want to do this to "recalibrate" the battery-used "meter". It harms battery life.
