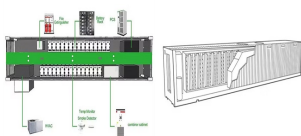
Why was the energy storage roadmap updated in 2022? The Energy Storage Roadmap was reviewed and updated in 2022 to refine the envisioned future states and provide more comprehensive assessments and descriptions of the progress needed (i.e., gaps) to achieve the desired 2025 vision.



Are energy storage installations eligible for ITC? Energy storage installations that are placed in service after Dec. 31, 2022, and begin construction prior to Jan. 1, 2025, are entitled to the existing ITC under Section 48 (a).

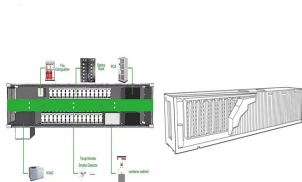


Could 20 GW of LDEs save the energy system \$24 billion? Analysis has found that deploying 20 GW of LDES could save the electricity system \$24 billion between 2025 and 2050, reducing household energy bills as additional cheaper renewable energy would be available to meet demand at peak times, which would cut reliance on expensive natural gas.

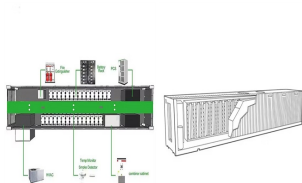

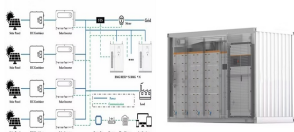

What is the applicable percentage for construction in 2022? The applicable percentage is (i) 10% for projects that begin construction in 2022, (ii) 12.5% for projects that begin construction in 2023, and (iii) 15% for projects that begin construction in 2024 or later.



Energy storage installations that are placed in service after Dec. 31, 2022, and begin construction prior to Jan. 1, 2025, are entitled to the existing ITC under Section 48(a). Call for applications under the Scheme "Energy storage facilities and related infrastructure for improving the stability of the Polish electricity grid" will be launched already this year. Subsidy contracts are to be entered into by the end of 2025, while the period for spending the funds ends with 2028.



The revenue mechanism for industrial and commercial energy storage is diverse. Numerous provinces, including Anhui, Guangdong, Hunan, Jiangsu, Zhejiang, and others, have implemented subsidy policies for C& I energy storage, with these subsidies expected to spur short-term installations of C& I ESS.



The scheme is scheduled to open on Jan. 1, 2025, and end in 2034. The funding is part of a 416 million subsidy program that was announced last year. The Dutch government said it would allocate the funds from the climate package issued in 2022, with the subsidies to facilitate the deployment of 160 MW to 330 MW of battery storage.

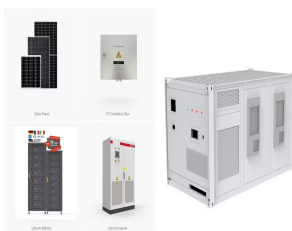

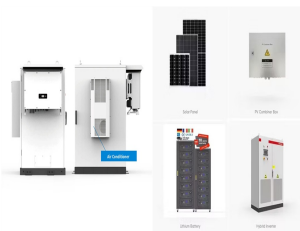
