Masdar, the UAE's flagship clean energy company, and its consortium partners, Infinity Power Holding and Hassan Allam Utilities, announced that they have signed a framework agreement with leading Egyptian state-backed organizations on the development of a 2 gigawatt (GW) green hydrogen project in the Suez Canal Economic Zone (SCZONE).



Infinity Power's existing operational portfolio across Egypt (where it operates the 252MW West Bakr wind farm), South Africa and Senegal comprises 1.3 gigawatts (GW) of solar power and onshore wind farms. The company is targeting 10GW of operational renewable energy in Africa by 2030 at an estimated investment of \$5 billion.



Infinity Power has acquired 100% of Lekela Power's shares for an unspecified figure, completing the biggest renewable energy deal in Africa's history. The transaction brings the energy provider's combined portfolio to 1.3 gigawatts (GW) across Egypt, Senegal and South Africa, with a 13.8GW pipeline in development, and makes the company the largest pure play ???

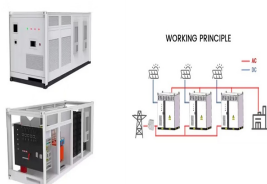

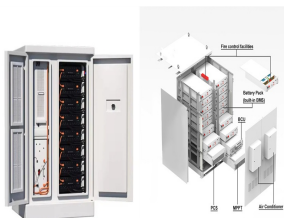

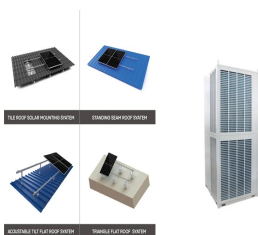
