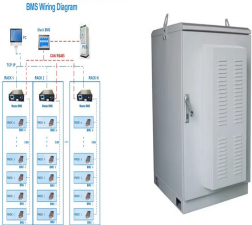
Why did Baytex buy Burmis Energy? In April 2008 it completed a \$181 million takeover of Burmis Energy Inc,a Calgary-based oil and natural gas producer (72% of production was natural gas) that was nine times smaller than Baytex at the time. The deal gave Baytex control of the Seal heavy oil property in Alberta and increased daily production by 3,650 boe.



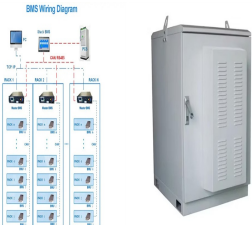
When did Baytex buy Aurora Oil & Gas? In June 2014Baytex acquired Aurora Oil &Gas Limited,which led to its significant new position in the EagleFord shale oil play in Texas. In 2014 Baytex 52-week high was \$49.88 and its 52-week low was \$14.56. For fiscal 2016 total production was 69,300 US bbl /d,8,260 m 3 /d,flat to the year before.
