A 30% federal tax credit is available to those who purchase a solar energy system. The tax credit is a dollar-for-dollar reduction in the amount of income tax you would otherwise owe; it is not a rebate or a government check. For example, claiming a \$1,000 federal tax credit reduces your federal income taxes due by \$1,000. If one does not have



Solar investment tax credit (ITC) enables you to deduct up to 26% of the total cost of installing and buying solar panels. Solar Sales Tax Exemptions. This solar tax incentive helps to reduce the upfront costs of installing a solar panel system, and there are currently 25 U.S. states that provide state sales tax exemptions.



If you install your photovoltaic system before the end of 2032, the federal tax credit is 30% of the cost of your solar panel system. This is 30% off the entire cost of the system including equipment, labor, and permitting. Example: If your solar energy system costs \$20,000, your federal solar tax credit would be $\$20,000 \times 30\% = \$6,000$.

As part of that effort, Colorado provides a state sales tax exemption (applicable to Sales and Use taxes) for homeowners' purchases of solar panels and other solar energy system equipment. This sizeable upfront tax exemption effectively reduces the solar panel cost .

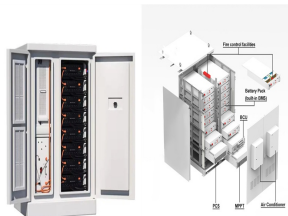

If you install a \$24,000 solar panel system, for example, then you'd qualify for a federal tax credit of \$7,200. That means your tax bill in the following year would be lowered by \$7,200.

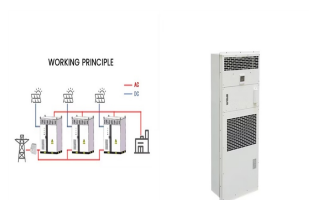


The previous income tax and sales tax obligations associated with the installation and operation of solar systems were recognized by policymakers as unnecessary hurdles, and the tax incentive beginning in 2023 is a complete tax exemption for smaller Photovoltaic systems on private house roofs or even on the balcony of a rented apartment (balcony power plants).
