

# BONAIRE SINT EUSTATIUS AND SABA BEMS ENERGY



What is the population of Bonaire Sint Eustatius and Saba? The total population of Bonaire, Sint Eustatius and Saba was 26,500 in January 2022. The population increased by 211 (+0.8 percent) compared to the previous year. The population is 26,500 with 48.4 percent being female and 51.6 percent being male.



Are Bonaire and Sint-Eustatius honoured? Late last week, the good news was received that the project proposals of Bonaire, Sint-Eustatius and Saba were honoured. They are the only islands in the Caribbean whose proposals made it through the selection.



Is Bonaire a sustainable island? Bonaire, a Caribbean island grappling with distinctive energy challenges stemming from its geography, population growth, and socio-economic disparities, has exhibited notable progress in transitioning from fossil fuels to renewable energy sources. Despite heavily relying on non-renewable energy, Bonaire is committed to enhancing sustainability.



How much does energy cost in Bonaire? This profile provides a snapshot of the energy landscape of Bonaire, a special municipality of the Kingdom of the Netherlands located on the coast of Venezuela. Bonaire's utility rates are approximately \$0.35 per kilowatt-hour (kWh), above the Caribbean regional average of \$0.33/kWh.



How does Bonaire's electricity system work? Presently, Bonaire's electricity grid operates autonomously, with 30% of its energy derived from renewable sources. The forthcoming decommissioning of the Morotin offshore wind farm by 2025 has catalysed collaborative efforts with stakeholders such as WEB, CGB, and BBT to devise an electrical system roadmap.

Does Bonaire have a regulated electricity sector? In recent years, the Ministry of Eco-nomic Affairs in the Netherlands has been active in reforming the regulation of the electricity sector in Bonaire, both in terms of utility regulation and expanding generator access.<sup>13</sup>



Bonaire, Sint-Eustatius and Saba are in the selected group of 30 islands that have been chosen by the European Union (EU) to take part in the "30 for 2030" project for energy transition. The islands, which were selected after an extensive selection process, can count on intensive support from the EU to realize their ambition to have fully

After the reformation of the Kingdom of the Netherlands in 2010, Cura?ao and Sint Maarten applied for a similar status to that which the country of Aruba already had since 1986 and have become more independent as autonomous countries, while Bonaire, Sint Eustatius and Saba (the so-called BES-islands) have decided to become part of The Netherlands.





Bonaire will relax the travel conditions for travelers from the BES islands (which consists of Bonaire, Sint Eustatius, and Saba) and the CAS islands (which consist of Curaçao, Aruba, and St. Maarten) from February 12, 2022. Fully vaccinated travelers from Curaçao, Aruba, and St. Maarten no longer need to take a PCR test to come to Bonaire.



Bonaire, St. Eustatius and Saba (the "BES islands"), have, as public entities, become part of the Netherlands. The Dutch Central Bank and the Dutch Authority for the Financial Markets ("AFM") have replaced the Central Bank of Curaçao and St. Maarten as financial supervisory authority on the BES islands.

Each island has a relatively small population: Bonaire (around 22,000), Sint Eustatius (around 3,200), and Saba (around 2,000) residents. Key economic sectors include tourism, particularly diving and nature-based tourism on Bonaire and Saba, oil storage and transshipment on Statia, and limited agriculture and small industries.

Attending the summit were the members of the Island and Executive Councils of Bonaire, St. Eustatius and Saba.
