Fighting has intensified in recent years so that now the Al-Qaeda linked Jama???at Nasr al-Islam wal Muslimin (Group for the Support of Islam and Muslims,JNIM) and,to a lesser extent,the Islamic State in the Greater Sahara,control up to 40 percent of Burkina Faso???s territory,the Economic Community of West African States reported.



Are Islamist armed groups causing retaliation in Burkina Faso? Repeated Islamist armed group attacks on villages and towns with impunity have spread fear in Burkina Faso and led to retaliatory killings. ???Islamist armed groups are adding to the misery of civilians caught up in the fighting by unlawfully cutting them off from food and humanitarian aid,??? Kaneza Nantulya said.



What happened in Burkina Faso in 2022? (Nairobi) ??? Islamist armed groups in Burkina Faso have killed scores of civilians,looted and burned property,and forced thousands to flee in attacksacross the country since late 2022,Human Rights Watch said today. The armed groups have also besieged several towns,cutting residents off from food,basic services,and humanitarian aid.



What happened in Burkina Faso? The Islamist armed groups have also besieged several towns in Burkina Faso???s Sahel and Est regions, blocking food, other necessities, and humanitarian aid to the civilian population and causing starvation and illness among residents and displaced people.



Is Burkina Faso a non-international armed conflict? Human Rights Watch has separately investigated the killing and enforced disappearance of scores of civilians since February by alleged Burkinab? armed forces in the Sahel region. The fighting between the Burkina Faso government and the armed groups qualifies as a non-international armed conflictunder the laws of war.





Where is the JNIM in Burkina Faso? Human Rights Watch is investigating the attack. The ACLED reported that the JNIM is active in 11 out of 13 of Burkina Faso???s regions. The ISGS thus far has only operated in the Sahel region, where the two armed groups have clashed.

On 24 August 2024, from 09:00 to 16:00, a group of JNIM terrorists opened fire on soldiers and townspeople who were digging defensive trenches for the army and the Volunteers for the Defense of the Homeland (VDP) ???a civilian armed group that supports the Burkinabe military. Hundreds of people were killed, while many wounded people were taken to a hospital in Kaya. Most of the victims were young residents of the town who helped soldiers dig trenches. Local offi???



This move could be to help staff a potential deployment to Burkina Faso. Several sources have claimed a few Wagner personnel arrived in Burkina Faso in late December to finalize a broader deployment with the Burkinabe junta. The prelude to Wagner's likely entry into Burkina Faso parallels the group's entry into neighboring Mali in 2021.
