Your old supplier can still be your licensee, and will continue paying you the same rate. A performance guarantee can be offered by your solar panel contractor or the solar panel manufacturers, and it could be included in the warranty. A performance guarantee ensures that your solar panels are operating at their highest possible efficiency. In the beginning, this should be as close to 100% as possible.



Installations using solar photovoltaic (PV), wind, hydro and anaerobic digestion (AD) technologies up to 5MW and fossil fuel-derived Combined Heat and Power (CHP) up to 2kW or "microCHP", (up to a maximum of 30,000 Eligible Installations) can receive FIT payments, providing all eligibility requirements are met.


