However, customs clarified that solar panels or modules with elements such as diodes or motors should be classified under specific HS Codes. The correct classification is under HS Code 8541.42.00.00 and 8541.43.00.00, which are subject to 0% duty and VAT-free import according to the ECOWAS Common External Tariff (CET) for 2022-2027.



The tariff code for solar panels is 85414011. What is HS code 85414012? HSN code 85414012 is for solar cells for the generation of electricity, including solar cells assembled in modules or made up into panels; mounted on a support with frames and other accessories.



"Solar panels is in 8501 called DC generator. It is anything that generates DC and 8501 talks about generators and other generating sets. Generating sets are 8502. Solar panels are made up of minute photovoltaic cells and photovoltaic cell put together can be used as a signal and they can also be used for power.



Solar Batteries Inverters for Solar Power Generators (both diesel and Petrol propelled) SI 32 of 2008 did not include solar panels as the substantive duty rate for solar panels had been set at 0% in the First Schedule to the Customs and Excise Act (also known as the Customs Tariff Book) since 1999. According to TARIC, customs duty for photosensitive semiconductor devices, including photovoltaic cells whether or not assembled in modules or made up into panels; light-emitting diodes, code 8541409000, is 0%. In the HTS tariff system, the duty for solar cells assembled into modules or made up into panels (code 8541.40.60.15) is also 0%.

But this potential solar intervention may be crushed by a price hike before it can take any hold. 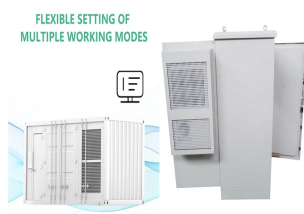

The South African Revenue Service (SARS) has announced a 10% import duty on solar photovoltaic (PV) panels, cells, and modules. This change, listed under tariff subheading 8541.43 in the Customs and Excise Act, raises the duty on crystalline silicon photovoltaic modules or solar panels from free to 10% ad valorem.
