How much does electricity cost in St Kitts & Nevis? The electricity rates in the Federation of St. Christopher (St. Kitts) and Nevis are \$0.26 per kilowatt-hour (kWh). This is lower than the Caribbean regional average of \$0.33/kWh.



Does St Kitts and Nevis have a national energy policy? Yes, St. Kitts and Nevis has a National Energy Policy (NEP). The key provisions of this policy include connecting large-scale independent power providers and many distributed renewable energy systems to the electrical grid. Not all generation is made publically available; this chart provides known and referenceable data.



How much energy is lost in St Kitts & Nevis? Reports indicate that in St. Kitts and Nevis, higher losses are largely attributable to nontechnical losses such as unmetered consumption, leading to losses that are higher than the U.S. Energy Information Administration's average transmission and distribution loss of 6%. By comparison, the U.S. Energy Information Administration reports an average transmission and distribution loss of 6%.
