How is EPBD being implemented in Gibraltar? How is it being implemented in Gibraltar? The Energy Performance of Buildings Directive 2010/31/EU (EPBD) was transposed by the Environment (Energy Performance of Buildings) Regulations 2012. This legislation came fully into force on the 4th October 2012.



What is an Energy Performance Certificate (EPC)? The Directive requires that all buildings be issued with an Energy Performance Certificate (EPC) upon construction, sale or rental. Please note that under the terms of this legislation a building is defined as one that uses energy to condition the indoor climate, i.e. buildings with fixed heating or cooling installations.



What is an EPC rating? An EPC provides a rating for the energy performance of a building. The ratings are standard so that the energy efficiency of one building can be easily compared with another building of a similar type. The ratings will look similar to a white goods energy rating where an 'A' rating indicates a high level of efficiency and G indicates a low level.
