How much does the government pay for energy storage? The Government also covers 30% of the energy storage costs. Eligible PV systems should feed maximum 60% of installed capacity into the grid, with the rest stored. There are no direct subsidies specifically for large-scale storage, but financial support may be available through the use of other incentive schemes.
