Florida Solar Panel lawsuits are getting more and more common. "Solar Panels are free!" 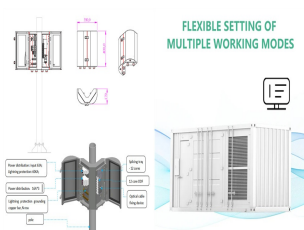

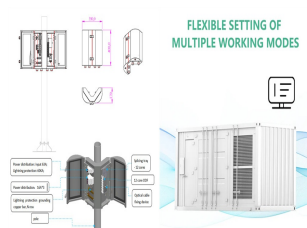
