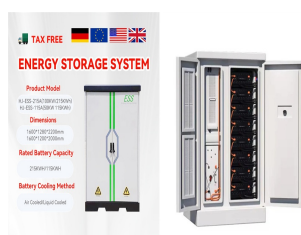

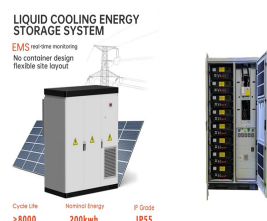

Starting in 2023, a utility can request an alternate net-metering rate structure "that is in the public interest and will not result in an unreasonable allocation of, or increase in, costs to



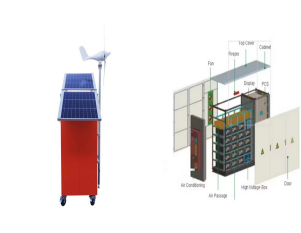
This segment currently accounts for more than 8.4 GW of Brazil's 13 GW of grid-connected solar power generation capacity. The new rules will introduce a new net metering regime from 2023, meaning PV systems installed this year will not be subject to grid charges from January 2023.

The LPSC's rules for distributed generation and net metering were initially approved in 2005. They were designed to incent distributed generation, particularly solar, by allowing customers to reduce their monthly electric bill with energy generated by a qualifying distributed generation system on their property.

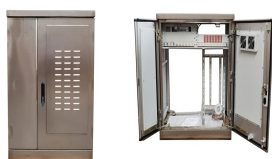

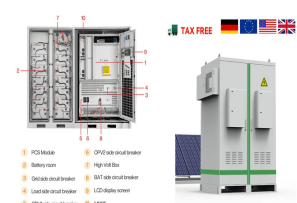
