What are Malta's feed-in tariffs & rebates? Malta has extended its feed-in tariffs (FITs) and a rebate scheme to support the adoption of residential solar and battery energy storage systems for another year. The authorities will start accepting applicants for the two initiatives again from Feb. 23.





What percentage of PV installations are in Malta? The government said it will provide further information on the bidding process in March. According to 2022 figures from Malta???s National Statistics Office,residential PV installations accounted for 93.5% of Malta???s total PV capacity,followed by the commercial and public sectors,which accounted for 5.7% and 0.8%,respectively.







Can I apply for a property grant in Malta? The applicant is not entitled to receive a grant if the property is used principally for business purposes, including the letting of the property on a commercial basis (even if the tenants' use of the property will be residential); technology from any other schemes that include national or public funds such as Government of Malta funds.

The scheme will be PDO's second solar IPP project. In 2019, it awarded the contract to develop a 100MW solar PV scheme in Amin to a team comprising Japan's Marubeni Corporation along with the local Oman Gas Company, the local Bahwan Renewable Energy Company and Qatar's Nebras Power.




The second scheme supports a battery-ready PV system with a hybrid inverter or separate solar inverter, and will benefit from a ???750/kWp grant and ???3,000 maximum grant on capital spend (up to 50%), and a 10c5 feed-in tariff. The third scheme supports new combined PV and battery storage systems which self-consumemore solar-generated electricity.





The Malta Solar Panels Scheme Recognizing the potential of solar energy, the Maltese government has implemented several initiatives and policies to promote its adoption. The introduction of the National Renewable Energy Action Plan (NREAP) and the Renewable Energy Scheme has been instrumental in incentivizing solar panel installations.

This control scheme gets the battery to: Charge from any excess solar generation remaining after offsetting the load until the battery is full. This occurs when generation > load.

The excess electricity will be exported to the grid or used to charge an on-site solar battery. Retailers will offer a payment, known as a feed-in tariff, which will appear as a credit on your bill. From 1 July 2025, a rate of 18.66 cents per kilowatt-hour will apply to electricity exported to the network from 3pm to 9pm.



The schemes presented will include battery ready PV systems with a Feed-In Tariff of 10c5/kWh for 20 years and a PV grant of ???3,000 (capped at 50% of Capex). Other packages include the PV system with battery storage.


