Does Nauru have an energy road map? Currently Nauru is working on an Energy Road Map, including action plans for the development of renewable energy and energy efficiency sufficient to significantly lower imports of diesel fuel for electricity generation.



How can Nauru reduce its reliance on fossil fuels? In order to achieve Nauru's ambitious goal of reducing the country's high reliance on imported fossil fuel by meeting 50% of its energy needs from renewable energy sources by 2015, the Nauru Government requested technical support from GIZ, SPC and IRENA in the development of a Nauru Energy Road Map in early 2012.



Why is Nauru so vulnerable to solar energy? Solar energy is the only proven renewable energy resource which could be utilised in short to medium term to reduce dependency on fuel imports for electricity generation. The country's vulnerability is also increased by its isolation from other Pacific Islands. In 2012, SPC released an energy profile of Nauru based on 36 energy security indicators.



Does the NUC provide electricity to Nauru? The NUC currently provides all electricity services to Nauru except for the RPC and the main processing plant of RONPHOS which both generate their own power. Diesel, petrol and jet fuel are purchased by the government for all customers except RONPHOS who do their own purchasing.



What does imported energy mean for Nauru? Imported energy for Nauru means fossil fuel imports. Unambiguous records of the quantity of fuel imports, their timing and the specific type of fuel imported are vital to the determination of the Nauru energy balance.

Why is Nauru relocating its key infrastructure? There is more work to be done. Many of Nauru's key assets are vulnerable to coastal related hazards including sea level rise, coastal erosion, storms, water intrusion and flooding which are projected to intensify due to climate change. Therefore, a long-term priority is to relocate key infrastructure to higher ground.

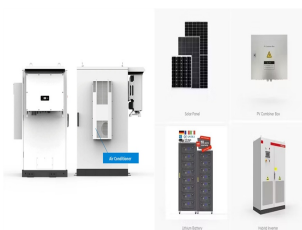

In July 2021 China announced plans to install over 30 GW of energy storage by 2025 (excluding pumped-storage hydropower), a more than three-fold increase on its installed capacity as of 2022. The United States' Inflation Reduction Act, passed in August 2022, includes an investment tax credit for stand-alone storage, which is expected to

S4 Energy, an energy storage project developer and a majority-owned subsidiary of Castleon Commodities International (CCI), has agreed to acquire a 310 MW portfolio of German battery energy storage projects from Teraa One Climate Solutions, a Germany-based energy storage project developer. The acquisition marks S4 Energy's entrance into the German market.



The NERM provides the implementation plan for Activities to facilitate Nauru's energy sector development agenda. The main energy efficiency target of the NERM 2014 - 2020 that has not been revised in the NERM 2018 - 2020 is, by 2020, to have: 30% improvement in energy efficiency in the residential, commercial and government sectors.



In terms of energy production, a 30% midday demand penetration (1 MWp of solar) represents around a 5% energy penetration for the conditions in Nauru so the 50% goal cannot be reached without substantial additional solar (above 1 MWp) which would need to be accompanied by associated energy storage such as large batteries.



Key renewable energy projects include the installation of a solar power plant and a battery energy storage system, supported by international funding and partnerships. Transitioning to renewable energy is expected to reduce electricity costs, improve energy security, and provide environmental benefits for Nauru.

Not surprisingly so, given the rapid rise of energy storage south of the border has put the US into a leading position among global markets.
