How long is an inverter warranty? Solar inverters are usually warranted for a period ranging from 5 to 15 years, with an average standard warranty period of 10 years. Some companies offer the possibility to extend this period to up to 20 years. See the table below for a sample list of inverter manufacturers and the warranty terms they offer.



The extension of the warranty period shall only be applicable to all above mentioned inverters. Ordering parties may apply for an extension of the warranty period for string inverters to a period of 5, 10 or 20 years in the aggregate. The warranty period of central inverters can be extended to a period of 10 or 20 years in the aggregate.
