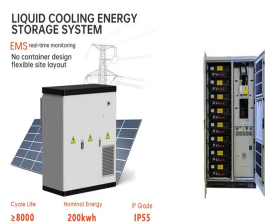


RANKINE ENERGY WESTERN SAHARA

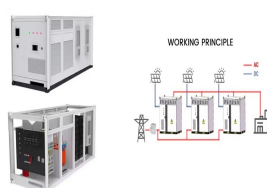
