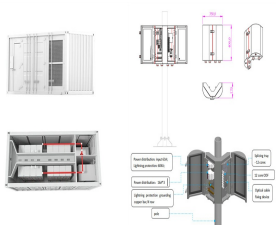


How did Saint-Pierre and Miquelon become a territory? After the 1958 French constitutional referendum, the territory of Saint-Pierre and Miquelon was asked to choose one of three options: becoming fully integrated with France, becoming a self-governing state within the French Community, or preserving the status of an overseas territory; it decided to remain a territory.
