Who owns a Taiwanese solar power development platform? Partners Group, the global private markets investment manager, has agreed to invest over USD 200 million as the controlling shareholder in a Taiwanese solar power development platform on behalf of its clients.



Will Taiwan triple its solar power commitment by 2025? Taiwan has unveiled plans to triple its solar power commitment from 6.2 GW to 20 GW by 2025. The agreement marks Partners Group's third significant solar platform investment on behalf of its clients for the last two years.



Can Taiwan develop a solar power plant? It has already sourced a number of sites throughout Taiwan, suitable for the development of rooftop and ground-mounted solar plants, and has others in due diligence. Once completed, the portfolio will be supported by a 20-year power purchase agreement with Taiwan's state-owned utility.



Why did Toshiba ESS invest in photon Taiwan Fund? Toshiba ESS decided to invest in Photon Taiwan Fund, L.P. in February 2021. With this investment opportunity, Toshiba ESS will actively pursue the development of renewable energy and Virtual Power Plant (VPP) projects in Asian
