Managers and members are assigned interest in the LLC under the governance of an Operating Agreement, with neither directors nor shareholders necessary. The St. Vincent and the Grenadines Limited Liability Companies Act 2008 allows the formation of both a Single LLC and a Series LLC.



How are St Vincent and the Grenadines international business companies formed? Saint Vincent and the Grenadines International Business Companies, IBCs, are formed by corporate legislation under the Companies Act. The Companies Act, Chapter 143 of the Laws of Saint Vincent and the Grenadines 2009 Revised Edition. St Vincent Company formation can be accomplished through an agent (such as this one).
