





Is Russia destroying Ukraine's energy infrastructure? One of the main targets of Russia???s ongoing attacks on Ukraine is the energy infrastructure. The extent of the destruction is enormous. ???One year after the start of the war in February 2022,76 percent of thermal power plants had been destroyed; now the figure is 95 percent,??? says Ukrainian scientist Iryna Doronina.





What is happening in Ukraine's energy system? Despite this, nuclear, hydropower, and newly constructed renewable projects continue to provide critical electricity. International partnerships have been pivotal in rebuilding Ukraine's energy systems. Companies such as GE Vernova and Honeywell are collaborating with DTEK on wind and battery storage projects.





Are Ukraine's power plants being attacked? The corresponding findings,to which researchers from the Technical University of Munich and the University of Bayreuth also made valuable contributions, have now been published in Joule, a leading journal for energy research. ???We???ve established that practically all Ukraine???s large, centralised power plants have been attackedsince February 2022.





Can a solar PV-plus-storage system improve resilience in Ukraine? 


