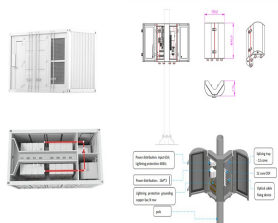


# TAX EXEMPTION FOR ENERGY STORAGE POWER STATIONS

Many states have either a solar or wind exemption, which provides that equipment used for electricity generation by either solar or wind be exempt from sales tax. Florida, for example, provides an exemption for solar energy systems, and New York provides a specific sales and use tax exemption for solar modules and panels.

The exemption will not apply to generating equipment used to make electricity from a conventional power source, meaning nuclear energy or a hydropower facility greater than 30 megawatts in size or a fossil fuel power plant, unless the fossil fuel is used for cogeneration of more than one useful energy output. The exemption is in a bill, A.B.



Sales and Use Tax Massachusetts imposes a five percent sales tax on all sales at retail of tangible personal property in Massachusetts by any vendor, unless an exemption applies. G.L. c. 64H, § 2, 6. Tangible personal property includes gas, electricity, and steam. G.L. c. 64H, § 1. Sales of gas, steam, electricity, and fuel are exempt from tax when the sales are for the production of electricity.



Income Tax Exemption for non-coal based private power company. Commencing operations between 1 Jan 2020 to 31 Dec 2022 100% exemption up to 31 Dec 2034. 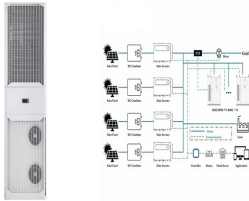

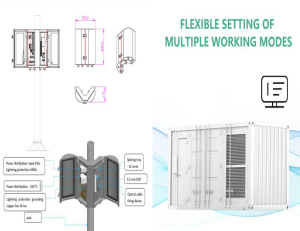

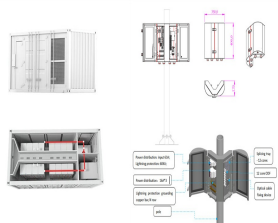

AB 1817 of 2018 created an exemption from the sales and use tax for "qualified tangible personal property purchased for use by a qualified person to be used primarily in the generation or production, or storage and distribution, of electric power." The exemption also applies to contractors who purchase the equipment in the service of a contract with a qualified ???



The proposed exemption, like the current exemption for solar energy systems, would allow local jurisdictions to opt-out and to continue to impose local sales tax on energy-storage systems. Currently, all but eight local taxing jurisdictions statewide have opted out of providing the solar-energy systems exemption and impose tax at the local level.



Direct pay is perhaps the greatest benefit for exempt organizations to come out of the Inflation Reduction Act of 2022 ("the Act"). Section 6417 was added to the Internal Revenue Code, allowing for an elective payment (also referred to as direct pay) of certain federal energy tax credits for "applicable entities," which includes exempt organizations.



New York City Solar and Energy Storage Property Tax Abatement provides a property tax abatement for building owners in New York City who install energy storage or solar energy systems. The annual abatement for energy storage systems is generally equal to the lesser of 10% of the energy storage system's costs or \$62,500. The



The invoicing tax rate for energy storage power stations primarily varies based on jurisdiction and regulatory frameworks. 1. In many regions, the tax rate is influenced by specific policies aimed at promoting renewable energy initiatives, typically ranging from 0% to a predetermined percentage of the sale price, 2.
