

Western Sahara used to be a Spanish colony until 1975. The UN demanded that Spain decolonize the area through a popular referendum, but neighboring Morocco and Mauritania both decided to claim the area as their rightful territory. So, no, Morocco is not holding on to West Sahara for its survival but rather because it wants to. Something
