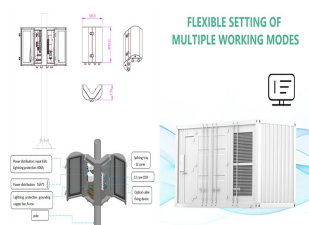


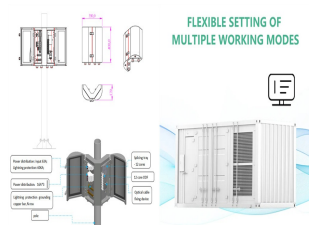

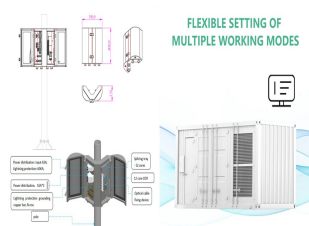
Is there a zero-rate VAT on solar panels? A zero-rate of VAT on the installation of energy-saving materials (ESMs), including solar panels, in residential accommodation, was introduced on 1 April 2022. At the time, it only applied to England, Scotland, and Wales. Following a new agreement between the UK and the EU, the zero-rating was also implemented in Northern Ireland on 1 May 2023.



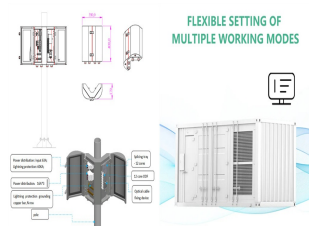

A zero-rate of VAT on the installation of energy-saving materials (ESMs), including solar panels, in residential accommodation, was introduced on 1 April 2022.



Are solar panels tax deductible in the UK? According to the UK government's list of Energy Saving Measures (ESMs), most solar photovoltaic (PV) panels installed on residential properties in Scotland, England and Wales (plus Northern Ireland, as of 1 May 2023) are exempt from VAT, meaning there's no VAT included in the purchase and installation costs.



Are solar thermal and PV systems subject to VAT? Solar thermal and PV systems are included on the list of ESMs. Their supply and installation are now subject to 0% VAT in Great Britain. In Northern Ireland, the previous rules remain in force. This means that solar is subject to 20% VAT unless a reduced rate of 5% applies.

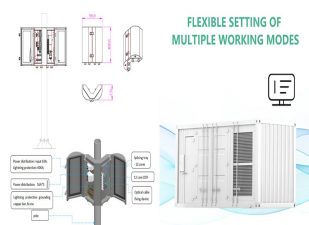


Are solar and energy storage installations subject to VAT? All solar and energy storage installations, including maintenance to existing sites, should be subject to 0% VAT. This should include residential energy storage when installed as a standalone measure.

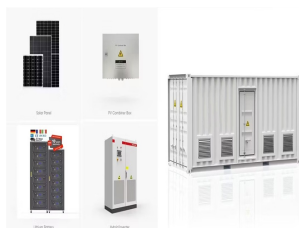

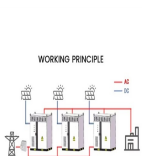

Income tax thresholds are due to remain the same until the 2028-29 tax year. From April 2028, they will increase in line with inflation. Income tax in Wales has been devolved to the Welsh government since 6 April 2019, but taxpayers living in Wales currently pay the same tax rates as those in England and Northern Ireland.



Different tax brackets, or ranges of income, are taxed at different rates. These are broken down into seven (7) taxable income groups, based on your federal filing statuses (e.g. whether you are single, a head of household, married, etc). The federal income tax rates for 2022 are: 10%, 12%, 22%, 24%, 32%, 35%, and 37%, depending on the tax bracket.
