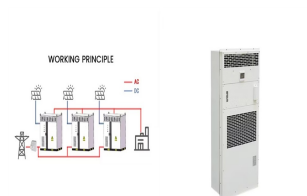

The solar farm that was commercially commissioned in April 2019, was developed and is owned by a consortium comprising Enel Green Power of Italy, a multinational renewable energy corporation, and the Industrial Development Corporation of Zambia (IDC), a parastatal company.

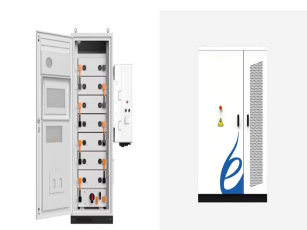
