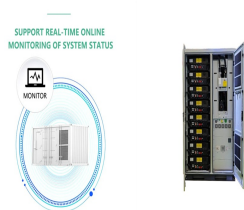

Following a drop in global oil prices, the Zambian Energy Regulation Board (ERB) has reduced the pump price of petrol by 23% and of diesel fuel by 28%. 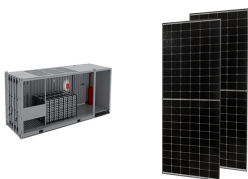

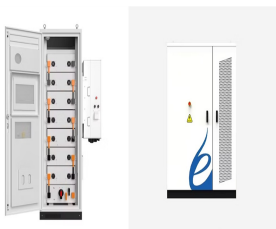
